

CONSENT TO THE PROCESSING OF PERSONAL DATA

Version as of September 1, 2026

An individual, the subject of personal data (hereinafter referred to as the “Data Subject”), by

providing data on the website  <https://anna-kott.com>

(hereinafter referred to as the “Website”), as well as when using the Operator’s/Content Provider’s platform and forms, freely, of their own free will and in their own interest, confirms their consent to the processing of their personal data by Individual Entrepreneur Kott Anna Vasilyevna (hereinafter referred to as the “Operator”, “Content Provider”).

1. ACTIONS WITH PERSONAL DATA

1.1. The consent is given for the processing of personal data both with and without the use of automation tools, including the following actions: collection, recording, systematization, accumulation, storage, clarification (updating, modification), retrieval, use, transfer (provision, access), depersonalization, blocking, deletion, and destruction of personal data.

2. PURPOSES OF PERSONAL DATA PROCESSING

2.1. The Data Subject’s personal data may be processed for the following purposes:

- Identification of the Data Subject as a Content User, registration on the Website, on the Platform and/or in the personal account, granting access to restricted sections, materials, lessons, live streams, chats, assignments, and other Content provided by the Operator.
- Conclusion, execution, amendment, and termination of agreements between the Data Subject and the Operator, including order placement, payment, granting access to Content, provision of services, support, and handling inquiries related to the agreement execution.
- Sending the Data Subject service, informational, and organizational messages related to order placement, access to Content, schedules, changes in service terms, order status notifications, technical support, account security, and other messages necessary for the agreement execution and the proper functioning of the Operator’s services.
- Processing inquiries, requests, applications, claims, and other messages sent by the Data Subject to the Operator.
- Providing the Data Subject with feedback, consultations, demonstration materials, information about Content, tariffs, services, and cooperation terms at the Data Subject’s request.
- Improving the operation of the Website, Platform, personal account, and user experience; conducting statistical and analytical studies; ensuring the correct operation of interfaces; saving user settings; and ensuring security and protection against abuse.
- Fulfilling the Operator’s obligations under the legislation of the Russian Federation, including tax, accounting, civil law, and other mandatory reporting, as well as interaction with government authorities and authorized organizations within the limits

prescribed by law.

2.2. This consent does not cover the sending of advertising, marketing, and news messages; such processing of personal data is carried out only upon the Data Subject's separate consent to receive advertising and marketing newsletters.

3. COMPOSITION OF PERSONAL DATA

3.1. The list of personal data for which consent to processing is given may include:

- Surname, first name, patronymic;
- Email address;
- Phone number;
- Telegram account;
- Other data that the Data Subject voluntarily provides when filling out forms on the Website, in the personal account, on the Platform, in questionnaires, surveys, registration forms, order forms, feedback forms, and other interfaces of the Operator, to the extent necessary to achieve the processing purposes specified in this consent and the Operator's Policy.

4. DELEGATION OF PROCESSING AND TRANSFER TO THIRD PARTIES

4.1. The Data Subject is informed that, in order to achieve the purposes specified in this consent and in the Operator's Personal Data Processing Policy, the Operator may entrust the processing of personal data to other persons on the basis of a contract or other appropriate legal ground, provided that such persons comply with the requirements of the legislation of the Russian Federation on personal data.

4.2. The Data Subject consents to the transfer of their personal data to third parties in the following cases and for the following purposes:

- To conclude and execute an agreement between the Data Subject and the Operator, including granting access to Content, providing services, processing payments, and ensuring the operation of the Website, Platform, and personal account;
- To fulfill the Operator's obligations under the legislation of the Russian Federation (including obligations related to tax, accounting, and other mandatory reporting, as well as interaction with government authorities and authorized organizations within the limits prescribed by law);
- In other cases where the transfer of personal data is expressly permitted by the legislation of the Russian Federation.

5. VALIDITY PERIOD OF THE CONSENT AND ITS WITHDRAWAL

5.1. The consent is valid from the moment it is provided until the purposes of personal data processing are achieved or until the retention periods for personal data expire, as established by the Operator's Policy and/or the legislation of the Russian Federation.

5.2. The Data Subject has the right to withdraw the consent at any time by sending a request to the Operator using the contact details specified in the Operator's Personal Data Processing Policy. If the consent is withdrawn, the Operator shall cease processing the Data Subject's personal data, unless there are other legal grounds for

their processing and storage.

6. CONFIRMATION OF ACKNOWLEDGEMENT OF THE POLICY
